Paper Guidelines and Research Session Organization

Academicians, researchers, professionals and graduate students are welcomed to submit their research in the aforementioned fields. Executive summaries should be concise and preferably sent as pdf. documents. Author guidelines for completed papers will be additionally provided via e-mail to accepted participants. We accept and encourage co-authorship.

Presentation

Each participant will have 10 minutes available for presenting their work. After each speech a 5 minute Q&A session will be conducted meant for sharing views, discussing open questions or receiving positive guidelines for future works and cooperation.

Please follow these time intervals to avoid presentation overlapping and disrupting the proposed agenda. We thank you in advance.
